This Certificate of Registration is awarded to Aum Pranavashram Trust, C-1-8, Five Falls Road, Ilanji Village, Tenkasi (T.K), Tenkasi District – 627 805 as an institution for children in need of care and protection vide S.No.1748/DSD/2022 under section 41(1) of the Juvenile Justice (Care and Protection of Children) Act, 2015. This certificate of registration is valid for five years from the date of issue and is subject to the following conditions:-

- 1. The Management should run the institution in accordance with Juvenile Justice (Care and Protection of Children) Act, 2015.
- Based on the infrastructure available at present, the institution shall admit a maximum of 32 Children (7 Boys and 25 Girls) only.
- 3. This certificate should be displayed prominently for the information of parents / general public in the office room.
- 4. The following words may be mentioned in the name board of the Institution Aum Pranavashram Trust, C-1-8, Five Falls Road, Ilanji Village, Tenkasi (T.K), Tenkasi District – 627 805 is registered by Director of Social Defence under Juvenile Justice (Care and Protection of Children) Act, 2015 as Children's Home.
- The services to the children shall be provided by the institution as per section
   of Juvenile Justice (Care and Protection of Children) Act, 2015.
- 6. The institution shall have a Management Committee in accordance with the Rules to manage the institution and monitor the progress of every child.
- Institution should follow rules / regulations issued by State Government / Director/ Commissioner of Social Defence from time to time.
- The Institution is subject to inspection by the inspection authorities under the Act / Rules and by the persons / officers authorized by the State Government / District Child Protection Society / Child Welfare Committee.

- Orders should be obtained from Child Welfare Committees for all admissions and discharge.
- 10. Any admission / death / repatriation of the children in the institution and any discharge of children from the institution should be intimated to the concerned District Child Protection Officer and Child Welfare Committee in accordance with Tamil Nadu Juvenile Justice (Care and Protection of Children) Rules, 2017.
- i) Structural Soundness Certificate issued by a registered Engineer under sub-section 4 of section 4 of the Tamil Nadu Public Buildings Licensing Act, 1965 (Act XIII of 1965) – valid up to 31.03.2025,
  - ii) License issued by the competent authority under sub-section (1) of section 6 of the Tamil Nadu Public Buildings Licensing Act, 1965 (Act XIII of 1965) - valid up to 31.03.2025,
  - iii) No Objection Certificate from Fire Service Department valid up to 30.08.2022,
  - iv) Sanitation Certificate issued under the Tamil Nadu Public Health Act,1939
     (Tamil Nadu Act III of 1939) valid up to 30.01.2023, should be renewed periodically before expiry date
- 12. The registration certificate is valid for the period mentioned therein and is subject to the condition that the certificates mentioned in 11 (i) to (iv) above are renewed in time before expiry and a copy has to be furnished to the District Child Protection Officer of Concerned District and to the Directorate of Social Defence.
- The Institution shall ensure proper education, child rights and necessary safeguards from child abuses.
- 14. The Institution shall ensure water and sanitation and also safe drinking water.
- 15. The Institution shall arrange recreation and motivation activities.
- 16. Rain Water harvesting facilities should be made in the Institution.
- 17. The Institution should not have any Thatched structure.
- Required number of firefighting equipment should be installed and personnel also should be trained in handling them.
- This registration shall be deemed to be withdrawn in case of violation of any of the conditions by the institution.
- Home management committee should be formed and conducted regularly as per rule 49 of Tamilnadu Juvenile Justice (Care and Protection of Children) Rules, 2017.
- All the staff and eligible Children of the Child Care Institution should be COVID-19 vaccinated.

The registration shall be subjected to the conditions laid down in the Juvenile Justice (Care and Protection of Children) Act, 2015 and the Rules made thereunder. The institution should comply with Rules / Regulations / Instructions issued by the State Government / Director of Social Defence from time to time.
